The specific cost for the expungement will be determined, and you will be notified by letter if there are fees. The average cost for an expungement is \$310, and payment must be in the form of a Money Order and it is Non-refundable. Processing an expungement is very time consuming and may take a MINIMUM OF 6-8 WEEKS OR MORE. Due to the high volume of expungement applications, your request may require some time, but we ask that you be patient through this process, and we request calls on the status of your application be kept at a minimum.
